



## POWER-OPERATED MEDICAL EQUIPMENT

Depending on the nature of the emergency, the first important decision you will need to make is whether to **STAY** or **GO** and **HAVE A PLAN FOR BOTH POSSIBLE SCENARIOS.**

To make an informed decision, follow the official sources of information and monitor TV, radio and official emergency alerts coming to your cell phone.

If **staying at home** is the safest and best option, consider that you will need to have **supplies, medications and resources to SELF-SUSTAIN for at least 7 DAYS.**

Including **alternative solutions** if the utility services are impacted by the emergency or disaster. Dangerous conditions might **stop** traveling: Including **9-1-1, Public transportation or meal deliveries**

**Creating an emergency plan for power operated medical devices, consider the following 3 steps:**

- 💡 **Teach others how to use your equipment** and ensure they understand the contingency of alternative power solutions.
- 💡 **Contact your utility provider** to talk about backup power options and keep a list of emergency power providers.
- 💡 **Find alternative power sources** and review your equipment's instructions

### EQUIPMENT USE

Battery dependent assistive technology and medical devices, **are equipment essential to your level of independence or vital to keeping you alive.** Some of these devices include: breathing machines (respirators, ventilators), power wheelchairs and scooters, oxygen, suction, or home dialysis equipment.

- ✚ Maintain **relevant information** about medical equipment organized in a waterproof bag that you can easily carry with you if you must evacuate. The information should include **medical device model, serial number, vendor information, and instructions manual on how to operate it.**
- ✚ Contact your insurance provider to see if you qualify for a **manual backup device** in case of a power outage or damage to your powered equipment.

## POWER-BACKUP CHECKLIST AND SAFETY

- **Ask a Professional**

- **Use generators outdoors and at least 20 FT AWAY from building openings**
- **PREVENT carbon monoxide poisoning**
- **During and after the emergency plan for having limited access to gas stations**
- **Follow fuel storage guidelines**
